

## Golf Voucher Scheme

A named person may apply for Corporate Social Membership. Upon approval, they may then purchase Golf Vouchers. These Vouchers may be distributed at the discretion of the Member to anyone within the same company. A voucher is the equivalent of a round of golf (18 holes).

### Conditions of Use:

1. Additional Membership Cards (up to four max) can be purchased at £25 each, which would allow access to the Levy Account.
2. Vouchers are to be used within the same year as the Membership. These may be carried over into the next year as long as Membership is renewed. All Vouchers have a maximum validity of 1 year from date of purchase.
3. Option 1 allows use of the golf course Monday to Friday only and Option 2 allows use of the golf course Monday – Sunday.
4. No access is given to Club Competitions.
5. A maximum of eight vouchers to be used per day at the weekend.
6. ID is required by at least one person from the company when using vouchers.
